



## CONSTRUCTION PROJECT INFORMATION FLYER CITY OF ST. AUGUSTINE

### **Project Goal: Fullerwood Watermain Replacement**

Replace close to 10,000 feet of various sized cast iron and galvanized water mains in the Fullerwood Area. This area has experienced color and pressure complaints due to aging metal pipelines in the distribution system. This is one of the oldest areas of St. Augustine. Goals are to provide more reliable water pressure and eliminate corrosion in the city mains. Project will replace aging pipelines with a combination of 8-inch and 6-inch PVC mains and new service lines and meters to the customer property lines. 148 Customers and 1 church will receive direct benefit from project.

### **Project Improvements**

Streets to have water mains replaced are:

- Hildreth Dr from San Marco Ave. to Atlantic Ave.
- Barbour Pl. from Hildreth Dr. to Atlantic Ave.
- North Park Ave. from Douglas Ave. to Atlantic Ave.
- Atlantic Ave. from N. Park Ave. to Cross St.
- Cross St. from Atlantic Ave. to Beacon St.
- Billings St. from Atlantic Ave. to Beacon St.
- Sylvan Dr from Douglas Ave. to E. Park Ave.
- Beacon St. from E. Park Ave. to Cross St.
- East Park Ave. from Sylvan Dr. to Rainey Ave.
- Bay View Dr. from San Marco Ave. to Douglas Ave.
- Macaris St. from Douglas Ave. to Rainey Ave.
- Douglas Ave. from Macaris St. to Hildreth Dr.
- Rainey Ave. from Macaris St. E. Park Ave.

#### **Note:**

New watermains will be installed along with new water services and meters.

After watermain project is complete, the city will be returning to Fullerwood neighborhood to pave the streets.

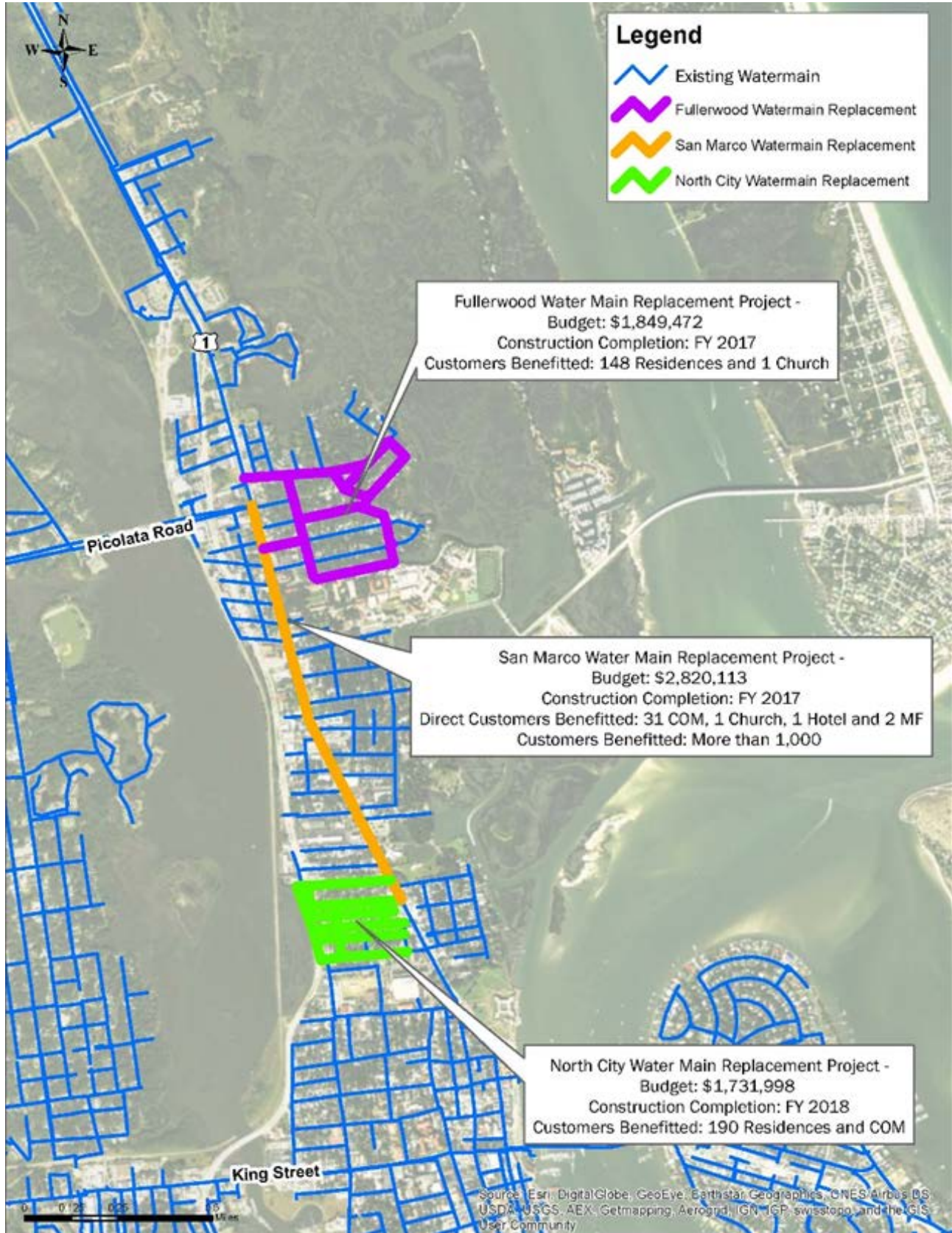

**Project Overview:** During the construction phase, the contractor will make every effort to provide access to resident's entrances to driveways, subdivisions and businesses during the day. There may be times when driveways or entrances may be inaccessible, but our intent is to minimize any inconveniences to the local residents and businesses during this project phase, and we ask for your patience as this project progresses. At the end of each weekday, the excavation areas will be backfilled and compacted; and all residential and business driveways should be accessible. The contractor will be videotaping the entire project area prior to starting the construction to verify the existing conditions. The contractor may also be contacting property owners to identify any irrigation systems located within the construction areas. Any damage caused by construction will be repaired by the contractor at no cost to the owner.
